The report of Sessional Committee II was introduced by the Vice-Chair-cum-Rapporteur, Mr. .Joannes Tandjung (Indonesia).

### (b) Designation of intergovernmental bodies for the purposes of rule 76 of the rules of procedure of the Board

The Board was informed that the list of intergovernmental organizations in status with UNCTAD was contained in TD/B/IGO/LIST/7, and that there were no new applications to be considered.

## (c) Designation of non-governmental organizations for the purposes of rule 77 of the rules of procedure of the Board

The Board was informed that the list of non-governmental organizations in status with UNCTAD was contained in TD/B/NGO/LIST/9. The Board approved one new application for observer status:

• The World Forum of Civil Society Networks (UBUNTU): the background information on this organization is contained in document TD/B/55/R.1.

### (d) Review of the calendar of meetings

The Board approved the calendar of meetings for the remainder of 2008 and the provisional calendar of meetings for 2009 as contained in a non-paper dated 26 September 2008.

### (e) Membership of the Working Party for 2009

The Board approved the membership of the Working Party for 2009 as follows: Albania, Belarus, China, Congo, Djibouti, El Salvador, Finland, France, Indonesia, Iran (Islamic Republic of), Japan, Mexico, Morocco, Peru, Philippines, Russian Federation, Sweden, Switzerland and United States of America.

## (f) Review of the lists of States contained in the annex to General Assembly Resolution 1995 (XIX)

There were no new applications for membership of the Board, which still stands at 151.

### (g) Administrative and financial implications of the actions of the Board

The Board was informed that the actions of the Board at its current session had no financial implications for the current programme budget.

### Item 15 Other business

#### Topics and terms of reference for expert meetings

The Board approved the compilation of topics and terms of reference as a whole contained in a non-paper dated 26 September and requested the secretariat to issue the compilation as an official document of the Board to be translated into all official United Nations languages.

#### **Executive session**

The Board requested the extended Bureau to meet in the following week to decide on the holding of an executive session in mid November and to approve its agenda.

### **Item 16** Adoption of the report

The Rapporteur, Mrs. Falkonaki-Sotiropoulos (Greece), introduced the draft report of the Trade and Development Board on its fifty-fifth session, as contained in TD/B/55/L.1; TD/B/55/L.2 and Add.1-9, TD/B/SC.1/L.1 and L.2 and TD/B/SC.2/L.1. The Board adopted the draft report and authorized the Rapporteur to complete the report for transmission to the General Assembly.

Mr. Supachai Panitchpadki, Secretary-General of UNCTAD, made a closing statement.

Closing statements were made by the following representatives: Mexico; Zimbabwe (on behalf of the Group of 77 and China); Indonesia (on behalf of the Asian Group); Kyrgyzstan (on behalf of Group D); Bangladesh (on behalf of the least developed countries); France (on behalf of the European Union); Peru (on behalf of the Group of Latin American and Caribbean States); and Chad (on behalf of the African Group).

The President of the Board made concluding remarks.
